

2nd Annual - Heroes and Hope Century Bike Ride

8 A.M. Start – Both rides - 50 or 100 miles

Experience the breathtaking beauty of Somerset County and two events that shaped our nation – the Flight 93 Memorial and the Quecreek Mine Rescue Site – on either a century or half-century bicycle ride.

The first 50 miles traverse the final miles of the heroes of Flight 93. The 100 mile ride covers that same course and also takes you to the heroic mine rescue site of nine local coal miners (“All nine are alive!”). Detailed maps to be available on our website (below) as Flight 93 park opening details become available this summer.

The cost is \$25 for riders registering by Sept. 1 and \$35 for those registering after Sept. 1 or the day of the race. Included in the registration is a T-shirt (while supplies last), drinks and snacks along the route, and a complete picnic meal afterward at the House of Hope farm.

For those accompanying riders to the event, picnic tickets for adults and children (12 and older) are available for \$5. Kids under 12 can eat for free.

Proceeds benefit House of Hope Laurel Highlands, a Christian counseling center for troubled teens and their families.
